Holytown is a town situated to the east of Bellshill and north of Motherwell in North Lanarkshire, Scotland. Most local amenities are shared with the adjacent villages of Carfin, Newarthill and New Stevenston which have a combined population of around 20,000 across the four localities.


LOCATION

Torrance Park Neighbourhood Centre occupies a prominent position beside the A723 at the entrance to Torrance Park a new residential district which on completion will comprise over 900 homes.

The A723 is a busy arterial route linking Motherwell, Carfin and Holytown to Junction 6A M8 motorway and Eurocentral and Newhouse Industrial Estate close by to the north of the subject site.

SITUATION

Torrance Park comprises a new residential neighbourhood where in excess of 500 new homes have been completed, with the remaining under construction as of June 2024.



TRANSPORT CONNECTIONS



ROAD

A723 which abuts the site is the main link road from the M8 (junction 6A) to Motherwell and then the M74 at Hamilton.



MOTORWAY

The M8 provides links to Glasgow to the west and Edinburgh to the east.



RAIL

Holytown railway station is located approximately 1.2 miles to the south accessed off Quarry Street via Jerviston Street and provides regular rail services to Glasgow and Edinburgh.

DESCRIPTION

The neighbourhood centre will comprise a single story terrace anchored by a 4,000 sq ft convenience store and 6 other units plus a stand alone pod unit within the car park.

The car park will provide 66 car parking spaces including disabled, parent and child and a electric vehicle hub for charging cars.

Full planning has been secured for the park as per Planning Permission 21/00288/FUL. The Additional pod will be subject to planning permission. The layout plan is indicative layout of planning consent and could be subject to change.

ACCOMMODATION

The units within the main parade will range in size from 750 – 4,000 sq ft and a pod unit extending to 2,000 sq ft.
